8.1. MOTION – DOMESTIC VIOLENCE IN TRANS NZOIA COUNTY (BY HON. RONALD MATONGOLO)

Mr. Speaker Sir,

I beg to move the following motion.

AWARE of the continued increase in cases of violence among married couples, against children and other vulnerable persons in the home and society.

AND AWARE that this state of affairs is compounded by various factors including;

- i. Poverty
- ii. Low literacy levels
- iii. Drug and alcohol abuse
- iv. Stress related causes due to high cost of living
- v. Disregard of family value among others.

Mr. Speaker Sir, we need to find a lasting solution to this problem because domestic violence has resulted in serious societal and family related problems such as;-

1. Increase in single families,
2. Child labour,
3. Increased drug and alcohol abuse,
4. Prostitution,
