8.9 MOTION – STANDARD PERCENTAGE OF THE MINIMAL WAGE FOR A SECURITY GUARD ‘WATCHMEN’
(HON. GEORGE MUKWANA MASIKA)

Mr. Speaker Sir,

AWARE of the tedious work done by security guards commonly known as watchmen, knowing that most of them are employed and deployed by registered security firms.

Mr. Speaker this house notes with great concern the frustration that these security companies are causing those working under them by paying them as little as Kshs. 2000/= while the company collects as much as Kshs. 15,000/= from their client for a single watchman.

Mr. Speaker, Concerned that even with such little money payments are delayed for several months;

Mr. Speaker sir, I urge this house to come up with legislation that will set a standard percentage of the minimal wage for a security guard ‘watchman’ basing on what clients are paying the security company for each guard and set datelines for salaries to be paid and job securities for all guards so that the firms don’t just hire and fire at their own pleasure.
