2. THE MANDATE OF THE COMMITTEES

The Joint sitting was mandated to discuss the Trans Nzoia County Flag, Emblem and other symbols Bill.

3. AGENDA

Pursuant to the above mandate the Committee's agenda was to examine the Trans Nzoia County Flag, Emblem and other symbols Bill and propose amendments thereof for subsequent consideration, debate and adoption by the plenary.

4. TRANS NZOIA COUNTY FLAG, EMBLEM AND OTHER SYMBOL BIL

The following clauses were **adopted without amendments**; **1**, **6**, **10** and **11**.

Interchange clauses 2 and 3

In **Clause 2** delete the words "County flag, seal, emblem and other symbols" in the definition of "County Assembly"

In Clause 2 introduce "Executive Committee Member means the Executive Committee Member for the time being responsible for legal affairs and public service"

Clause 3 (b) to read as follows "To provide for the use of the County flag, emblem and other Symbols to promote County and National unity"

Delete clause 4 (b)

In clause 4 (c) delete the words "part III of"

In clause **5** introduce the word "the" between "to" and "punishment"

In clause 5 delete the word "County" between the words "the" and "symbols"

In clause **5** replace the words" in this Act" with "in that Act"

In clause **7 (1) (a)** introduce the words "emblem or other symbol" between "flag" and "by"

In clause 7 (1) (b) delete the words "or within view of" between "in" and "any"

In clause **7 (1) (b)** introduce the words "emblem or other symbol" between the words "Flag" and "in".

In clause **8 (2)** delete the words *"Members of the"* between *"The"* and *"Executive"* and introduce *"Member"* between *"Committee"* and *"may"*

In clause **9 (1)** introduce the words "and instances" after "occasions"

In clause **9 (f)** delete the word "All" before "County" and introduce "semi colon" then the words "Village polytechnics, County hospitals, health centres and such other institutions "after the word "centres"

In clause **9(2)** delete the word "Members of the" between "The" and "Executive" and introduce "Member" between "Committee" and "may".

Clause 12 was deleted as it was a replication of clause 4 (d).

Clause 13 then became clause 12

In clause **12** (b) introduce the words "and hoisted" between the word "flown" and the semi colon.

In clause 12 (c) replace the word "Second' with First"

In the First Schedule the;

- Symbol (a)" THE COUNTY EMBLEM"; replace the flower plant with a two leave tea plant
- Symbol (b) "THE COUNTY SEAL" replaces the flower plant with a two leave tea
- Symbol (c) "THE COUNTY FLAG"; replace the cork wheel with the COUNTY EMBLEM and delete the words TRANS NZOIA.
